

# End-of-Sale and End-of-Life Announcement for the Cisco Secure Access Control System 5.0

### EOL7287—Amended

Cisco announces the end-of-sale and end-of life dates for the Cisco Secure Access Control System 5.0. The last day to order the affected product(s) is May 6, 2011.
